Regular board meeting
Minutes November 7, 2022

Call to order

DK from Norlina Fire Department came to announce that the Christmas Parade will be December 17th at 5pm and to notify everyone that Highway One will be closed from 4pm-6pm that day. He announced that anyone interested in signing up to be in the parade or a vendor to supply food can find the

necessary paperwork at either the Norlina Fire Department or Aycock Auto Service. There is no entry fee to participate but donations will be accepted. No motorcycles can be in the parade and the only music allowed is Christmas music, no exceptions. The tree lighting will be done after the completion of the parade. DK asked that the businesses on Hyco St. participate by decorating their businesses as well.

Commissioner Tyrone Simes announced that the Petition for annexation for the 72 acres paperwork has been done and processed (see packet).

Charles Smiley made a motion to approve the petition for the voluntary annexation, seconded by Commissioner Claude O'Hagan; all were in favor.
