Mayor Aycock reported passing of budget.

Blaine Reese reported regarding sewer project, 2 wells: wet well and dry well reported to be set this week, Crane has been delivered, pits have been dug. Progress meeting set for following day and are set for 2nd Tuesday of each month. Reported delay of generator at port due to tariff issue.

New Business.

Upcoming Town elections. Greg Loyd reported trying to get the Town on even years for elections so the town could save funds on election costs. Commissioner Simes addressed regarding staggered terms for Commissioners.

Train Car Grant: Blaine reported that Greg had started some leads to turn historic train car into Warren County tourism center. Blaine is following up with possible grants for refurbishment. Mr. Fields inquired regarding new apartment complex. Blaine reported that the were zoning permits for first 3 houses.
